



Interstate 40 - Exit 123 East Seligman Bridges

BRIDGE DECK REHABILITATION PROJECT



OVERVIEW

The Arizona Department of Transportation, in conjunction with the Federal Highway Administration, is planning to reconstruct and replace the east- and westbound bridge decks on Interstate 40 at exit 123 near Seligman in Yavapai County. The project is needed to replace the damaged elements of the bridges, and perform other upgrades to increase the lifespan of the bridges.

WHAT TO EXPECT

Construction is scheduled to begin spring of 2022 with a shutdown during the 2022-23 winter season, project completion is anticipated fall of 2023. During construction, I-40 will be reduced to one lane only in each direction, and crossovers will be constructed to shift traffic to one side of the interstate while work on the bridge in the other direction takes place. Access to all adjacent properties will be maintained during daytime hours. At times there will be night closures on B40 at I-40 for demolition, installing and removing falsework, and concrete pours. All on and off ramps will remain open.
